Imminent deep changes in the way men organized and design the physical environment demand to architects and to all the disciplines involved to adapt theoretical, methodological and practical new knowledge in order to improve the quality of our environment.

If you are interested, please send immediately the registration form. PHD Students, Master Students, Professors and Research Groups are invited to send abstracts of one page DIN A4 in English or Spanish for this conference in Barcelona, before the 31st January 2015 to this e-mail newsletter.pa@upc.edu. Later on, in October 2015, the full papers will be included in the web www.arquitectonics.com and a selection will be published in the International Journal Arquitectonics. The nine topics of the conference, the registration fees and the application form are included in this communication.

The three settings for research where the design based upon knowledge will be developed are: The educative setting, the professional setting and the social setting, they will include works where the relationships between critical theories, methods and practices are relevant for the environmental dimensions of the human life.

The diagram included here is a very condensed organizational of the nine topics of the conference where educational, professional and social participation papers are classified in the three categories of: theory and practice, evaluation of knowledge (assessment), and production of knowledge. Interdisciplinary orientations will be appreciated. Each of these nine topics will constitute a specific network of the general association **ARQUITECTONICS.**

A brief description of the nine topics follows. (See www.arquitectonics.com for more information and also the following publications: International Journal Arquitectonics, Critical Spaces (LIT VERLAG, Wien-Berlin, 2014), IAPS Publications, First International Conference on Gaudí (www.gaudicongress.com) publications from the ENHSA and EAAE networks, etc.)

In order to have a better definition of the architectural knowledge, analyzed by Aristotle as a "practical wisdom", or "phronesis" it is necessary to study the theoretical, methodological and practical conditions of this "phronesis" in education (topic 3), in the profession (topic 6) and modernity and tradition in planning (topic 9). Of course the three perspectives are tied together, but the conditions are different. Then in education (topic 1) conditions are related to the way interdisciplinary knowledges are tied to design and the way architecture is taught in the university. In the profession, the study of theories and practices should analyze the work of architects such as Steven Holl, Peter Zumthor or Rem Khoolhas, etc. that made a huge effort in order to explain design form practice to theory and form theory to practice (topic 4). And in planning, topic 7 articulates new theories, methods and practices in planning such as the Alberto Magnaghi proposition (Territorialisti in Florence: www.societadeiterritorialisti.it) or to the new strategies for renewal of the historical heritage.

In relation to these three topics 1, 4 and 7, devoted to the "production of knowledge" in education, the profession and planning, it is essential to analyze the work from within the professional studio (interdisciplinary or not) the educative institution or the social setting of planning participation, both in the past and today, and to show how "knowledge" is produced inside the practical processes in detailed fashion. It is very important to realize that.

The three topics, 2, 5 and 8, about evaluation, assessment and sustainability point to the study of built environments, schools or urban and landscape environments, in order to analyze if the results follow the expectations. They are post-occupancy and include not only the university level but the children participation in planning (Friendly Child Cities, web: ciudadesamigas.org) as well as high school or University experiences. In profession and in social participation experiences, the post-occupancy research includes assessment procedures for the evaluation of buildings and public spaces after construction and planning.

Summing up: the three first topics 1, 4, 7 define knowledge produced "inside the practices"; the topics 2, 5, 8 define knowledge "after the practices" and the three last topics 3, 6, 9 want to propose a better relation between theories, methods and practices in the different settings. They act "before practices" in order to innovate them but in a close relationship with all the other topics.
